- 3). That their seniority in the new Circle(s) of BSNL will be fixed strictly in accordance with the provisions of such **mutual transfers**, contained under Rule-8 of BSNL's Employee transfer policy.
- 4). That the pay of the executives on such transfer will be fixed under the Rule FR-22.
- 5). That they will forego all claims for confirmation in the old Circle(s) even if the permanent vacancies were available or become available because of retrospective permanency of a post or for any other reasons and are not entitled for confirmation against such post(s) in the old Circle(s).
- 6). That the officers have to forego all their claims towards their service rendered in their parent circle(s) for seniority / confirmation etc.
- 7). That these transfers are also subject to all other conditions mentioned in the letter(s) / Memo(s). already issued / to be issued in this regard from the O/o The Chief General Manager, BSNL Odisha Telecom. Circle, Bhubaneswar as well as from O/o The BA / OA Heads, Kharagpur under BSNL West Bengal Telecom. Circle / Balasore under BSNL Odisha Telecom Circle.


