This promotion order is not to be effected by the concerned Circle/Unit in case any disciplinary/vigilance case is pending or executive is under currency of any penalty or any of the circumstances enumerated in DoPT OM No. 22011/4/91-Estt. (A) Dated 14.09.1992 at the time of promotion. Such cases, if any, may be brought to the notice of this office immediately for taking further appropriate action.

3. Concerned CGMs/PCE(Elect)/CE(Elect) shall ensure that the promoted executives are relieved in time to enable them to join their promoted post at the assigned place of posting at the earliest. The above mentioned executives shall

join in the promoted post at the respective places of postings within 40 days from the date of issuance of this order positively failing which the promotion order shall become inoperative and thereafter, such executive/s shall not be allowed to join the promoted post. Such matters may be immediately reported to this office for further appropriate action. Further, no request for modification of posting, etc. shall be entertained.

4. No leave shall ordinarily be granted to the executive until he/she joins the promoted post. Further the executive under transfer to other Unit/Circle may be relieved immediately to join the promoted post immediately and within the specified time.

5. The pay of the executives promoted shall be fixed in accordance with provisions of BSNL MSRRs-2009 read with extant instructions in this regard.

6. The above promotion order is being issued after obtaining the vigilance clearance from Vigilance Branch of BSNL CO. However, in case, it comes to the notice of the concerned controlling authority that any disciplinary case is pending or any penalty is in operation against the executive, the executive should not be promoted without obtaining the specific approval of this office. Information in this regard may be brought to the notice of this office forthwith.

7. In terms of latest DoPT guidelines *vide* their OM dated 12-04-2022 in the matter of reservation in promotion, since the Jarnail Singh batch of cases is pending in the Hon'ble Supreme Court, this promotion order shall be subject to further orders that may be passed by Hon'ble Supreme Court in the said batches of cases and also subject to outcome of any other court cases in the connected matters.
