4. That the executives have no claim for posting in any particular station of new SSA/Circle.
5. That, they will have no claim for repatriation to their parent circle before completion of five years of service in the new SSA/Circle.
6. Their claim for the benefit of promotion on having qualified in the departmental examination while working in the parent unit will be permitted subject to the condition that a request to this effect is made by them within a period of six months of declaration of the result.
7.
